Reference was made to the horse ranch property on Fourth Ave. has a change in ownership, escrow should be contacting the office to clear the account balance owed to the water district.

Dave Nervino: Dave brought to the board's attention at the GSA meeting MCWD does not own parcels of land. When the district needs to redo a well site there needs to be more variations of how far the well can be moved over, cannot just move over fifty feet onto another parcel because we do not have them, an acceptation should be made for all water districts go by the rules as to where to relocate but give more leant in well placement. Dave brought up the developing of a mailing list for the 218 votes to be mailed out to only property owners who irrigate land. Dave also mentioned there has been several parcels owners who irrigate but never received the mailed ballot for the vote. The 218 votes will sunset in 2025, the GSA board mentioned then there will be another 218 vote to keep it going. Dave brought up there should be a panel of two people from each GSA to discuss what projects should be worked on then go to DWR and apply for money to fund projects.

Larry Mattos and Joe Nacimento of River Rock attended the meeting to discuss the wastewater residue issue from their facility. Larry is willing to fix issues the dairy has to satisfy MCWD standards of no wastewater in district pipeline. Larry requested a letter be sent to River Rock approving their entitlement.
