Director Rick Jones stated there should be further discussion with SWD and the sub-committee concerning the formation of a joint MCWD/SWD SGA.

# Motion approving Modesto Properties' well appraisal, not to exceed \$2,500.

Director Rick Jones explained himself and Adam Azevedo met with Modesto Properties regarding Modest Properties purchasing the well at that site. Director Adam Azevedo stated they have the first right of refusal of purchasing the MCWD portion of the well site.

There needs to be an appraisal for the well site in order to sell it.

Director Rick Jones found an appraiser to do the appraisal.

Director Danny Drumonde stated that there was something said that Wodesto Properties wanted to take the pumping allocation with them.

Director Azevedo stated we are not selling an allotment of water, were only selling the physical pump structure and electrical service. The pumping history is MCWD pumping history.

Engineer Eric Swenson stated this well is the only well MCWD operates that is pumping sub-Corcoran. The question is: does MCWD want to drill their own sub-Corcoran well because those are the only wells that pump 2,000 gpm?

A consideration for Modesto Properties may be what will happen with allocations for pumping in the future.

Director Rick Jones asked can MCWD transfer the water being pumped from this well?

Eric responded once the allocations are set up, it will be switched to a farmed acre basis on what our allocation is. So having or not having that well will not change MCWD allocation, what can change is the ability to pump that water, there may need to be an additional two and a half above Corcoran Clay wells to replace this well.

Mike Brazil asked what the letter from DWR is for? Eric Swenson responded there is verbal approval DWR has given for the revised GSP.

Moved by Director Danny Drumonde, seconded by Director Fred Oliviera approving Modesto Properties well appraisal, not to exceed \$2,500.

Notice of Vacancy for Lafco

#### **Civil Engineer Eric Swenson:**

1. <u>Discussion:</u> Update on Vierra well. One additional form was required by MCDEH for the well permit: Property Domestic Well status declaration. Coordinating with Dave Vierra to sign this declaration.

Eric now has the permit for Vierra well.

2. <u>Discussion/Action</u>: Approval of Water Wheeling Agreement with SWD. No action was taken at an earlier Board meeting regarding this item. Proposed fees from SWD for wheeling are \$25/AF for up to 3 miles and \$2/AF for additional mileage. Proposed wheeling losses are 5%/mile with a maximum loss of 15%. There has been some discussion about billing SWD for Wheeling through MCWD laterals. Section 6.3 of the 2007 Agreement discusses use by SWD of the Stoerk and Sprole Ditches. Irrigation under Section 6.3 is limited to water applied to a maximum of 260 acres of Stevinson lands located outside of MCWD. A fee of \$6.50/acre is noted in the Agreement with no inflation escalator. The Agreement does not state what this \$6.50/acre pays for.

Director Freddy Oliviera stated that MCWD needs to talk with SWD for clarification due to the terminology in the agreement.

Mark Green will come in to sign paperwork for the replacement of well 10.

The Board directed the District Engineer to submit the application for replacement well 10 electrical services with PG&E.

The Board concurred with proceeding with test well on Coelho property.

President Adam Azevedo requested a meeting just to discuss wells, ad hoc committee meeting. Director Rick Jones, Director Freddy Oliviera and anyone from the public may attend.

#### **Matter for the Good of The District**

Mike Brasil asked if there will have to be another 218 vote if MCWD forms their own GSA? Adam Azevedo stated there has to be funding to support the GSA in some form, so most likely will be.

Jimmy requested Doug Wells to attend the meeting to address if he is interested in the possibility to lease his well to MCWD, they use the well so frequently it does not seem feasible to him.

Frank Amaral stated he would be willing to lease his well on the corner of Second Ave and Cemetery Road to the District.

#### Office

Crystal received her Notary Stamps, she will now be available for Notary Services

Crystal uploaded all meeting minutes on the website to make it possible to search the internet for anything they want to look up.

AIG returned the employees retirement funds to MCWD; Crystal sent the check to Merced County so they can deposit the funds to the new retirement account. The air conditioner is fixed.
