SUBJECT: POTENTIAL FORMATION OF ADDITIONAL GROUNDWATER SUSTAINABILITY AGENCIES (GSA)

#### SUMMARY:

This item provides the Board with the opportunity to discuss potential impacts and actions for the Merced Subbasin GSA, should new GSA's express interest in forming in the Merced Subbasin. Staff has become aware that there are landowners within the Merced Subbasin GSA's boundaries who have expressed the interest or intention to form their own water district in order to form their own GSA.

According to the California Department of Water Resources, once exclusive GSAs are established in a basin, new GSAs may only be formed if the exclusive GSA chooses to peel back their boundaries and allow the new GSA to form. The Merced Subbasin GSA is the exclusive GSA for its portion of the Merced Subbasin.

## REQUEST/RECOMMENDATION/ACTION NEEDED:

Discussion regarding the potential formation of additional Groundwater Sustainability Agencies in the Merced Subbasin and impacts to the Merced Subbasin GSA.
