Dave Nervino asked if these number account for pre and post season water. The District Engineer answered that this was only for water sold from April 1 through September 30. Adam Azevedo responded no because the pre and post season water is purchased and sold for the same amount as purchased for.

Director Rick Jones stated he is personally opposed to the increase price at +2AF/acre, he stated he would want water rates to understand step up after 3AF/acre but not 2AF/acre. District Engineer stated the 218 votes set the increase to be at +2AF/acre, the pricing can be set to just one fee for all acre feet of water used.

Director Rick Jones stated he would like to review 2023 season numbers and see how rates would be affected if 2024 was similar to 2023. District Engineer will coordinate with Jimmy and gather usages for 2024.

No decision on water rates for 2024 was made at this meeting,

- 1. Discussion: Agreement with Frank Amaral private Irrigation Well.
 Frank Amaral has decided he no longer wants to allow the District to lease his well at
 Cemetery Road and Second Ave.
- Discussion: Well 10R Status Updates
 Quality Well Drillers plans to drill the test hole on Thursday, February 15th. PG&E has
 provided the build drawing for the electrical services. Director Danny Drumonde
 asked if "well #7 has been hooked up yet. District Engineer stated it may be another
 week out.
- 3. Discussion: MSGSA update
 - a. Letter of Intent to Form a New GSA: MSGSA voted to table this item and directed MSGSA staff to develop a path to continue consideration of this request. MSGSA indicated that all participants in the GSP would have to approve of this new GSA formation including Turner Island GSA and MIUGSA.
 - b. Allocation Policy Framework: a DRAFT framework was presented on aroundwater allocation.

c. Contract amendment with EKI. A \$80,000 contract amendment was approved directing EKI to develop groundwater allocations for all sustainability zones for above and below the Corcoran Clay Layer

Danny Drumonde and Jimmy met with Priority Ag Imigation MCWD would like to have them do some work for the district but, due to them not holding a current contractors license Merced County will not make payments to them.

District Engineer stated he and Jimmy discussed installing a 24 in stand at well 10R, for the discharge on from the well.

With the excessive weather several trees blew over, they have been cutting up trees.

A couple sweet potato farmers are requesting to use wells for their hot beds. Jimmy asked how the district would want to bill this out. The board replied it has in the past as cost plus 10%.

Priority Well use agreement will be added to the next meeting February 28, 2024.
